PART 58: GOOD LABORATORY PRACTICE FOR NONCLINICAL LABORATORY STUDIES

Before a drug or medical device can be tested in humans, it must undergo animal or laboratory testing to evaluate safety. Part 58 establishes Good Laboratory Practice (GLP) standards for these nonclinical studies, covering

personnel, facilities, equipment, and recordkeeping. Compliance with GLPs is essential for the validity of data submitted to the FDA.

PARTS 210 AND 211: CURRENT GOOD MANUFACTURING PRACTICE (CGMP) FOR DRUG PRODUCTS

Perhaps the most widely known sections of Title 21 for pharmaceutical manufacturers are Parts 210 and 211. These parts outline the minimum requirements for the methods, facilities, and controls used in manufacturing, processing, packing, and holding of drug products. CGMP regulations cover everything from raw material testing and equipment cleaning to documentation, quality assurance, and complaint

handling. Failure to comply with CGMP can lead to recall, shutdown, or legal action.

PART 820: QUALITY SYSTEM REGULATION (QSR) FOR MEDICAL DEVICES

This part sets requirements for design controls, purchasing controls, production and process controls, acceptance activities, and corrective and preventive actions (CAPA). PARTS 100-169: FOOD LABELING AND SAFETY

For food products, Part 101 is the core regulation for nutrition labeling, ingredient declarations, and health claims. Recent updates to Nutrition Facts labeling and the declaration of added sugars are incorporated into Title 21, reflecting evolving public health priorities. Additionally, the FDA Food Safety Modernization Act (FSMA) has introduced new preventive control rules codified in Title 21, such as Part 117 (Current Good Manufacturing Practice, Hazard Analysis, and Risk-Based Preventive Controls for Human Food).

PARTS 1300-1399: CONTROLLED SUBSTANCES (DEA)

Chapter II of Title 21 contains regulations enforced by the Drug Enforcement Administration. These parts govern the manufacturing, distributing, dispensing, and prescribing of controlled substances (e.g., opioids, stimulants, depressants). Pharmacists, physicians, and researchers must be familiar with registration requirements, security controls, and recordkeeping obligations under these parts.

Staying Current with Updates to Title 21
