In contrast to the more critical treadmill theory, ecological modernization offers a more optimistic view. It argues that modern industrial societies can reform themselves through technological innovation, market-based solutions, and smart regulation. Proponents point to

examples like Germany's shift toward renewable energy or the rise of corporate sustainability reporting. The assumption is that economic growth and environmental protection can be compatible—even mutually reinforcing. This perspective is popular among policymakers and business leaders because it suggests we can solve environmental problems without fundamentally disrupting the existing social and economic order. However, critics argue it underestimates the depth of the crises and the power of entrenched interests.

## World-Systems

# Analysis and Environmental Inequality

This perspective zooms out to the global level. It argues that the modern world-system is divided into a wealthy "core" (North America, Western Europe), a poorer "periphery" (much of the Global South), and a "semi-periphery" (emerging economies). Core nations have historically extracted resources and labor from the periphery, and they continue to export their environmental problems—like hazardous waste and high-polluting industries—to less powerful countries. **An Invitation To**

# Racism

- **Meat and Consumption:** The social and cultural drivers of high meat consumption, the environmental footprint of animal agriculture, and the growing interest in plant-based diets and

alternative proteins.

## Population, Consumption, and Technology

Discussions about the environment often focus on population growth, particularly in the Global South. Environmental sociology offers a more nuanced view. It argues that consumption patterns, especially in wealthy nations, are a far greater driver of environmental impact than population numbers alone. The average American consumes resources at a rate many times higher than the average person in India or Nigeria.

Furthermore, the field critically examines the role of technology. While technology can offer solutions (e.g., renewable energy, carbon capture), it can also create new problems (e.g., e-waste, the resource-intensive nature of electric vehicle batteries) and may create a "rebound effect" where efficiency gains lead to increased overall consumption.
