- **Coordinated Transportation:** A robust, multi-modal transportation network is essential, connecting towns and cities with rail, bus, and bicycle routes, reducing dependence on automobiles for

inter-city travel.

- **Economic Equity:** Fiscal policies should be structured to prevent the concentration of wealth and poverty, ensuring that all communities within the region have access to quality education, employment, and services.
- **Respect for Local Character:** The charter emphasizes that new development should respect the local history, culture, and geography of a place, avoiding cookie-cutter designs that could be anywhere.

5. **Connected by a Fine-Grained Street Network:** Instead of a hierarchical, dendritic system of cul-de-sacs and arterial roads, neighborhoods should have a grid-like or interconnected network of streets that disperses traffic and offers multiple routes.

This neighborhood model, often referred to as the Traditional Neighborhood Development (TND), stands in stark contrast to the typical subdivision. It prioritizes the pedestrian experience and fosters a sense of belonging and identity.

## THE BLOCK, THE STREET, AND THE BUILDING

The final layer of the charter zooms in on

the human-scaled details that make a community feel safe, comfortable, and engaging. It provides guidance on the design of the public realm and the architecture that defines it. Key principles at this scale include:

- **Active Frontages:** Buildings should address the street with windows, doors, and porches, creating a sense of visual interest and natural surveillance. Blank walls and parking lots are discouraged at the street edge.
- **Defined Public and Private Space:** Clear transitions between the public realm (the street and sidewalk) and the private realm (the home or shop) are essential, often achieved through stoops, low

fences, or courtyard walls.

- **Comfortable Street Design:** Streets should be designed to slow traffic and to accommodate pedestrians, cyclists, and parked cars, not just moving vehicles. Features like narrower lanes, curb extensions, and street trees contribute to a safe and pleasant environment.
- **Architecture that Fits Its Context:** While not mandating a single style, the charter calls for architecture that responds to the local climate, history, and building traditions, creating a cohesive and authentic sense of place.

Together, these three scales form a powerful, integrated system. The

**Charter For The New Urbanism** argues that you cannot have a great city without great neighborhoods, and you cannot have great neighborhoods without well-designed streets and buildings.

- **Urban Revitalization:** In older cities, the principles of the charter have been used to reclaim underutilized waterfronts, transform obsolete industrial sites

into vibrant neighborhoods, and improve the livability of historic districts through traffic calming and streetscape improvements.

Professional organizations like the Congress for the New Urbanism (CNU) continue to champion the charter, hosting events, publishing research, and training a new generation of planners and designers in its methods.
