- **Berberine** (from goldenseal and barberry)

- **Probiotics** (to restore the beneficial flora that compete with fungi)

For more severe cases, Kaufmann does not reject medical antifungals like fluconazole or nystatin, but he stresses that diet is the foundation—without removing the fuel, fungi will simply grow back. He also warns that die-off reactions (Herxheimer reactions) can occur when large numbers of fungi are killed rapidly, releasing toxins. This can temporarily worsen symptoms, and he advises a slow, stepped approach under supervision.

EVIDENCE, CRITICISM, AND THE GREAT DEBATE
