THE AXIAL REGION: CORE SUPPORT AND PROTECTION

The vertebral column,

or spine, is a marvel of design consisting of 33 vertebrae in five regions: cervical, thoracic, lumbar, sacral, and coccygeal. It houses the spinal cord and provides attachment points for deep back muscles that maintain upright posture. The ribs, attached to the thoracic vertebrae, form a protective cage around the heart and lungs. The diaphragm, a dome-shaped muscle, contracts to draw air into the lungs. Key muscles in this region include the trapezius, rhomboids, and erector spinae, which stabilize the trunk. The skull, composed of 22 bones, encases the brain, while the facial bones form the structure of the face. The temporalis and

masseter muscles are powerful jaw closers essential for chewing.

THE UPPER EXTREMITIES: MOBILITY AND MANIPULATION

The shoulder girdle, consisting of the clavicle and scapula, connects the arms to the trunk. The humerus, the upper arm bone, articulates with the scapula at the shoulder joint—a highly mobile ball-and-socket joint that allows a wide range of motion. Muscles like the deltoid, pectoralis major, and latissimus dorsi move the arm. The forearm contains two bones—the radius and ulna—which allow rotation of the wrist. The hand is an intricate assembly of 27 bones (carpals, metacarpals,

and phalanges) manipulated by a complex network of extrinsic and intrinsic muscles. The thenar muscles control the thumb, enabling the opposable grip that defines human dexterity. Tendons and ligaments in the wrist and fingers are susceptible to overuse injuries, such as carpal tunnel syndrome, highlighting the delicate balance of this system.

THE LOWER EXTREMITIES: LOCOMOTION AND SUPPORT

The pelvic girdle, made of three fused bones (ilium, ischium, pubis), forms a strong base for the legs and bears the weight of the upper body. The femur, the longest and strongest

bone, extends from the hip to the knee. The patella (kneecap) protects the knee joint and improves leverage for the quadriceps muscle. The lower leg consists of the tibia (shinbone) and fibula. The foot, with 26 bones and numerous joints, provides a stable platform for standing and a spring for walking and running. Major muscle groups include the gluteal muscles (gluteus maximus, medius, minimus) which extend and abduct the hip; the quadriceps group that extends the knee; the hamstrings that flex the knee; and the calf muscles (gastrocnemius, soleus) that point the foot. The Achilles tendon, the largest tendon in the body, connects the calf

muscles to the heel bone and is a common site of injury in athletes.

Common Conditions Affecting Muscles and Bones

Despite the strength and resilience of the musculoskeletal system, several conditions can impair its function. Osteoporosis thins and weakens bones, increasing fracture risk, particularly in the hip, spine, and wrist.
