The Primary

The key distinction here is that the company itself does not receive any money from trades in the secondary market. The money goes from one investor to another. However, the secondary market is incredibly important for the health of the primary market. It provides **liquidity**, meaning investors can easily convert their shares into cash. If you buy a stock, you want to know you can sell it quickly if needed. The secondary market guarantees that

liquidity, which makes investors willing to buy shares in the primary market in the first place.

KEY PARTICIPANTS IN THE EQUITY MARKET

- **Issuers:** These are the companies that list their shares. They are the "supply" side of the market, seeking capital for growth.

Listed vs. Over-the-Counter (OTC) Markets

Most major companies are "listed" on major exchanges like the NYSE or the London Stock Exchange, which have strict listing requirements regarding financial reporting, governance, and market capitalization. However, there is also the Over-the-Counter (OTC) market. This is a decentralized market where smaller, riskier, or foreign companies

that do not meet exchange requirements trade. OTC stocks are often subject to less regulation and can be more volatile.

Developed vs. Emerging Markets

Geographically, equity markets are categorized by economic maturity. **Developed markets** like the US, Japan, and Germany are stable, highly regulated, and liquid. **Emerging markets** like China, India, and Brazil offer higher growth potential but come with higher risks, such as political instability or currency fluctuations.

NATURE OF EQUITY INVESTING

Market Risk (Systematic Risk)

Volatility

Equity prices can be volatile, meaning they can swing wildly up and down in short periods. This can be stressful for short-term traders but is often less concerning for long-term investors who focus on the underlying value of the business.

The reward for taking on these risks is the potential for high returns. Historically, equities have outperformed bonds, real estate, and commodities over long periods (decades), making them a cornerstone of wealth-building strategies.
