Process Improvement and Technical Skill Development

- Identify and implement at least three process automation opportunities within the current fiscal year that collectively save a minimum of 200 hours of manual work annually, documenting the time savings and error reduction achieved.
- Complete advanced training in SQL or Python for data analysis, and apply these skills to build a repeatable data extraction pipeline that reduces report generation time by 30% by the end of the first half.
- Develop a standardized checklist and workflow for onboarding new analysts, reducing the ramp-up time from 90 days to 60 days by providing clear documentation and mentorship guidelines.
