- **Abiotic factors** set the stage for life. For instance, precipitation determines whether a region

becomes a rainforest or a desert.

- **Biotic factors** modify the abiotic environment. Trees create shade, roots hold soil, and decomposers recycle nutrients.

Understanding this relationship is central to the principles of terrestrial ecosystem ecology because it explains why different ecosystems occur in different places and why they behave differently under stress.

## ENERGY FLOW AND TROPHIC DYNAMICS

---

Energy flow is perhaps the most fundamental principle in terrestrial ecosystem ecology.

Every ecosystem requires a constant input of energy, primarily from the sun. This energy is captured by primary producers—plants, algae, and cyanobacteria—through photosynthesis. From there, energy passes through the ecosystem via feeding relationships known as trophic levels.

## Primary Production and the Base of the Food Web

Gross primary production (GPP) is the

total amount of energy captured by producers. Net primary production (NPP) is what remains after producers use some energy for their own respiration. NPP represents the energy available to the rest of the ecosystem. In terrestrial ecosystems, NPP varies widely, from the lush productivity of tropical rainforests to the sparse output of deserts and tundra.

This variation directly influences the complexity and diversity of the food web. High NPP supports more consumers, more predators, and more intricate interactions. Low NPP constrains the number of organisms that can survive in a given area.

# Trophic Levels and Energy Loss

Energy moves through trophic levels—producers, primary consumers (herbivores), secondary consumers (carnivores), and tertiary consumers (top predators). However, only about 10 percent of the energy at one level is transferred to the next. The rest is lost as heat through metabolic processes. This principle, often called the 10 percent rule, explains why there are so few top predators compared to

the number of producers.

Understanding trophic dynamics is essential for managing ecosystems. When a top predator is removed, for example, the effects cascade down through the food web, often with unintended consequences for vegetation and nutrient cycling.

1. Energy enters ecosystems through photosynthesis.
2. Energy is transferred between trophic levels via consumption.
3. Energy is lost as heat at each transfer step.
4. Ecosystems require continuous energy input to

sustain  
themselves.

## **NUTRIENT CYCLING AND BIOGEOCHEMICAL CYCLES**

While energy flows through an ecosystem and is ultimately lost as heat, nutrients cycle. This distinction is critical in terrestrial ecosystem ecology. Nutrients such as carbon, nitrogen, phosphorus, and potassium are essential for life, and they move between living organisms, the soil, the atmosphere, and water bodies in cycles.

## **The Carbon**

## **Cycle**

Carbon is the building block of life. In terrestrial ecosystems, carbon is captured from the atmosphere during photosynthesis and stored in plant biomass and soil organic matter. When organisms respire, decompose, or burn, carbon is released back into the atmosphere. The balance between carbon uptake and release determines whether an ecosystem is a carbon sink (net uptake) or a carbon source (net release).

Forests, especially old-growth forests and peatlands, are major carbon sinks. Disturbances such as deforestation, wildfire, or drought can flip them into sources.

Understanding this cycle is vital for climate change mitigation strategies.

## The Nitrogen Cycle

Nitrogen is often the limiting nutrient in terrestrial ecosystems, meaning that its availability constrains plant growth. The nitrogen cycle involves several key processes: nitrogen fixation (converting atmospheric nitrogen into usable forms by bacteria), nitrification, assimilation, ammonification, and denitrification.

Human activities have dramatically altered the nitrogen cycle through the use of

synthetic fertilizers and the burning of fossil fuels. Excess nitrogen can lead to eutrophication of adjacent water bodies, loss of plant diversity, and soil acidification. The principles of terrestrial ecosystem ecology help us predict and manage these impacts.

## The Phosphorus Cycle

Phosphorus is another critical limiting nutrient, particularly in older soils. Unlike carbon and nitrogen, phosphorus does not have a significant atmospheric component. It cycles locally through rock weathering, plant

uptake, decomposition, and sedimentation. Because phosphorus is relatively immobile in soil, its availability often limits productivity in many terrestrial ecosystems. Understanding these cycles and their interactions is central to ecosystem management. Healthy nutrient cycles support productive and resilient ecosystems. Disrupted cycles lead to degradation.

### **ECOSYSTEM STRUCTURE AND FUNCTION**

---

Structure refers to the physical arrangement of ecosystem components—the layers of vegetation, the distribution of species, the architecture of roots and canopies. Function

refers to the processes—photosynthesis, decomposition, nutrient uptake, water movement. The principles of terrestrial ecosystem ecology emphasize that structure and function are tightly linked.

## **Vertical and Horizontal | Structure**

In a forest, vertical structure includes the canopy, understory, shrub layer, and forest floor. Each layer has distinct light, moisture, and temperature conditions, supporting different communities of organisms.



Horizontal structure refers to patchiness across the landscape—gaps in the canopy, streams, rocky outcrops, and meadows.

This heterogeneity is not random. It arises from disturbances, soil variation, and the activities of organisms themselves.

Heterogeneity enhances biodiversity by providing a variety of niches. It also affects ecosystem function by influencing water flow, nutrient cycling, and energy capture.

Beavers build dams, creating wetlands. Earthworms aerate soil and accelerate decomposition. Trees create shade and modify microclimates. These ecosystem engineers shape the structure of their habitats and, in doing so, influence ecosystem function.

Recognizing the role of key species in maintaining ecosystem structure is an important part of applied ecosystem ecology, especially in restoration projects.

## **DISTURBANCE, SUCCESSION, AND RESILIENCE**

Disturbance is a natural and recurring feature of terrestrial ecosystems. Fire, windstorms, floods, volcanic eruptions, and

outbreaks of pests or diseases can alter ecosystem structure and function dramatically. The principles of terrestrial ecosystem ecology include understanding how ecosystems respond to disturbance.

# Ecological I Succession

Succession is the process of change in species composition and ecosystem structure over time following a disturbance. Primary succession occurs on newly exposed surfaces with no soil, such as lava flows or

glacial retreats. Secondary succession occurs on sites where soil remains after a disturbance, such as abandoned farmland or burned forests.

During succession, pioneer species are often fast-growing and adapted to high-light conditions. Over time, they are replaced by more competitive species that can tolerate shade and lower resource availability. Eventually, a relatively stable community, often called a climax community, may develop. However, in many ecosystems, disturbances occur frequently enough that climax communities are rarely achieved.

# Resilience and Resistance

Resilience is the capacity of an ecosystem to recover from disturbance and return to its original state. Resistance is the ability to withstand disturbance without changing. Different ecosystems have different levels of resilience and resistance. For example, a grassland may be highly resilient to fire, regenerating quickly from roots and seeds. A slow-growing forest may be less resilient to severe drought.

Human activities often

reduce resilience by simplifying ecosystems, removing key species, or altering disturbance regimes. Restoring resilience is a major goal of ecosystem management.
