## UNDERSTANDING THE OHIO DISSOLUTION PROCESS: A COMPLETE GUIDE

When a marriage reaches its end, couples in Ohio have two primary legal paths to end their union: divorce and dissolution. While both legally terminate a marriage, a dissolution is often a more amicable, cooperative, and streamlined process. Understanding **how to file for a dissolution in Ohio** is crucial for couples who agree on all terms—property division, spousal support, child custody, and parenting time—and want to avoid a contentious court battle. ## What Is a Dissolution and How Does It Differ from a

## Divorce?

In Ohio, a dissolution is a joint legal action where both spouses voluntarily agree to end their marriage. Unlike a divorce, which can be filed by one spouse even against the other's wishes (contested or uncontested), a dissolution requires mutual consent. Both parties must sign a separation agreement that resolves all issues, and neither can back out after filing without starting over. This cooperative approach often makes dissolution faster, cheaper, and less stressful than divorce, particularly for couples who have already reached a fair settlement outside of court.

### STEP 1: CONFIRM YOU MEET OHIO'S RESIDENCY AND ELIGIBILITY REQUIREMENTS

---

Before you can begin the filing process, you must satisfy Ohio's legal prerequisites. Ohio Revised Code Section 3105.61 states that at least one spouse must have been a resident of the state for a minimum of six months immediately preceding the filing. Additionally, the county where you file must be the county of residence of either spouse for at least 90 days prior. If you or your spouse have lived in Ohio for less than six consecutive months, you may need to wait before filing. Also, note that dissolution is only available to legally married couples—domestic partnerships and common-law marriages

are treated differently.

## No-Fault Basis Requirement

Ohio does not require you to prove fault (e.g., adultery, cruelty) for a dissolution. The sole grounds are "incompatibility," which simply means you both agree the marriage cannot continue. This no-fault approach encourages cooperation and reduces conflict, making the process more straightforward.

### STEP 2: REACH A FULL AND FINAL AGREEMENT ON ALL TERMS

---

The cornerstone of any Ohio dissolution is a comprehensive **separation agreement**. This legally binding contract must address every aspect of your marital dissolution. You cannot file a dissolution until you and your spouse have fully agreed on all the following elements:

- **Division of marital property and debts:** List all assets (real estate, vehicles, retirement accounts, bank accounts, personal property) and liabilities (mortgages, credit card debt, loans). Specify who gets what and who is responsible for each debt.
- **Spousal support (alimony):** Determine whether either spouse will pay support, the amount, duration, and terms for modification or termination.
- **Child custody and parenting time:** Designate legal custody (decision-making authority) and residential placement. Create a detailed parenting schedule,

including holidays, school breaks, and summer vacation.

- **Child support:** Calculate support using Ohio's Child Support Guidelines Worksheet, and include provisions for healthcare, extracurricular expenses, and life insurance.
- **Tax implications and other matters:** Decide who will claim exemptions for dependents and how to handle filing status for the year of dissolution.

It is strongly recommended that each spouse consult with their own attorney when drafting this agreement. Even if you are on good terms, an attorney can ensure your rights are protected and that the document meets legal standards.

### STEP 3: PREPARE AND FILE THE REQUIRED FORMS WITH THE COUNTY COURT

---

Once you have a finalized separation agreement, you must file a petition with the Court of Common Pleas in the appropriate county. The specific forms may vary slightly by county, but the essential documents include:

1. **Petition for Dissolution of Marriage (Form 1.0):** This is the main document that states both spouses' names, date of marriage, separation date, residency facts, and that you agree to the dissolution. Both spouses must sign it.
2. **Separation Agreement (Form 1.1 or similar):** Attach the full agreement executed by both parties. Some counties require the agreement to be notarized before filing.

3. **Affidavit of Income and Expenses (local form):** If you have minor children, you may need to submit this financial affidavit along with the child support computation worksheet.
4. **Parenting Proceeding Affidavit (UCCJEA):** Required if you have minor children. This discloses any prior or pending custody cases involving the children.
5. **Waiver of Service of Process:** Since dissolution is joint, both spouses waive formal service of process. This can be a simple written waiver attached to the petition.
6. **Military Affidavit:** Some counties ask you to certify whether either spouse is in the military, as special rules apply to service members under the Servicemembers Civil Relief Act.

You can obtain these forms from the county clerk's office, the Ohio Supreme Court's website, or your attorney. Fill them out carefully, ensuring all signatures are in the correct places. You will then file the originals with the clerk and pay the filing fee, which ranges from \$200 to \$400 depending on the county.

## Notarization Requirements

Ohio law requires that the petition and separation agreement be signed in the presence of a notary public. Both spouses must appear before a notary simultaneously or separately to acknowledge their signatures. Many county clerks provide notary services for a small fee. Do not attempt to file unless your documents are properly notarized,

as the court will reject them.

### STEP 4: THE 30-DAY WAITING PERIOD AND AUTOMATIC ORDERS

After filing, Ohio imposes a mandatory 30-day waiting period before the court can finalize the dissolution. This waiting period begins automatically upon filing; it cannot be waived. During this time, the court issues **standard automatic orders** that prohibit both spouses from:

- Selling, transferring, or hiding marital assets without mutual written consent or court order.
- Changing beneficiaries on life insurance or retirement accounts.
- Harassing or threatening the other spouse or children.
- Incurring excessive debt that would affect the marital estate.

These orders are meant to preserve the status quo and protect the interests of both parties until the final hearing. Violations could delay the dissolution or result in penalties.

### STEP 5: ATTEND THE FINAL HEARING (ONCE THE WAITING PERIOD ENDS)

After the 30 days have elapsed, the court will schedule a brief, informal hearing. Both spouses must appear in person (unless the court grants a remote appearance). The hearing typically lasts 15–30 minutes. The judge will ask a series of questions to confirm that:

- You and your spouse voluntarily and freely entered into the separation agreement.
- You understand its terms and believe they are fair and equitable.
- You have not been coerced or defrauded into signing.

- If you have minor children, the agreement serves their best interests.

No testimony about marital misconduct or fault is allowed. If the judge is satisfied, he or she will sign the **Decree of Dissolution**, officially ending the marriage. The decree incorporates your separation agreement, making it legally binding and enforceable.

---

### ADDITIONAL CONSIDERATIONS FOR COUPLES WITH MINOR CHILDREN

---

If you have children under 18, the court must approve the child-related provisions. The judge will review the parenting plan and child support calculation to ensure compliance with Ohio law. Be prepared to provide pay stubs, tax returns, and other financial documents supporting the child support calculation. Some counties also require the parents to complete a **parent education program** (often called a "Families in Transition" class) before the hearing. Check with your local domestic relations court for specific requirements.

## Modifying Your Separation Agreement After Finalization

Once the decree is entered, the separation agreement becomes a court order. If circumstances change (e.g., job loss, relocation, child's needs), you may file a motion to modify certain terms, especially child support, spousal support, or parenting time. However, property

division is generally final and cannot be altered unless both parties agree to a modification in writing and the court approves.

### COMMON MISTAKES TO AVOID WHEN FILING FOR DISSOLUTION IN OHIO

---

While the process is designed to be simpler than divorce, many people still encounter pitfalls. Avoid these errors to ensure a smooth filing:

1. **Incomplete or inaccurate forms:** Missing signatures, incorrect dates, or failing to disclose all assets can lead to rejection or future legal challenges. Double-check every line.
2. **Not having separate legal advice:** Even in an amicable dissolution, it is wise for each spouse to hire an independent attorney to review the separation agreement. A "one-lawyer" situation can create conflicts of interest and may invalidate the agreement later if one spouse claims they did not understand it.
3. **Assuming you can back out after filing:** Unlike a divorce, once you file a petition for dissolution, either spouse can withdraw consent up until the final hearing. If that happens, the case cannot proceed as a dissolution. You would then have to start over with a divorce action.
4. **Forgetting to update estate planning documents:** After dissolution, update your will, trust, powers of attorney, and beneficiary designations to remove your ex-spouse unless you intend otherwise.

### 5. **Failing to consider tax**

**consequences:** Property transfers between spouses as part of a dissolution are generally tax-free, but spousal support payments are taxable income to the recipient and deductible by the payer (for agreements executed before 2019 – new rules apply for later agreements). Consult a tax professional.

If you and your spouse cannot agree on even one term, or if one spouse refuses to cooperate, dissolution is not an option. You would need to file for divorce. Likewise, if you suspect hidden assets, domestic violence, or significant power imbalances, a divorce (potentially contested) may provide more legal protections. A consultation with a family law attorney can help you determine which path is appropriate for your situation.

## **HOW LONG DOES A DISSOLUTION TAKE AND WHAT DOES IT COST?**

---

The minimum timeline is about 30 days plus the time it takes to prepare documents and secure a hearing date. Most uncontested dissolutions are finalized within 6 to 8 weeks. The cost includes the filing fee (\$200-\$400), attorney fees (if you use one, typically \$500-\$2,000 per spouse for an uncontested matter), and notary/publication fees. Compared to a contested divorce that can cost thousands and take months or years, dissolution is significantly more affordable and efficient.
